Under UK GDPR and the Data Protection Act 2018, you have the right to see or be given a copy of personal data we hold about you. To gain access to a copy of your information, you will need to make a Subject Access Request (SAR) to the Practice. You can do so by completing and returning a <u>Subject Access Request Form</u> or contacting us by another method. There are some conditions where access to some information we hold about you may be restricted, for example if disclosure could cause serious harm to the physical or mental health of the data subject or another individual.

Under the Freedom of Information Act 2000, you have the right to request copies of non-personal information held by the Practice. To gain access to a copy of your information, you will need to make a Freedom of Information (FOI) Request to the Practice.

Should you wish to make a complaint to the Practice, then there may be a need for them to view and access your patient data or request some from you directly.
