

#### LSEBN Work Programme 2019-2020 (FINAL v5)

This report provides the first draft work programme for the ODN Board in March 2018. The document sets out the proposed priorities for the LSEBN and network team in 2018-2019.

#### 1 Introduction

1.1 The LSEBN has developed a work programme each year since 2013-2014. As in recent years, our programme is a mixture of local network issues and national projects, where it has been agreed that a single national approach is beneficial.

Our work programme is aimed to be aligned with national policy and Programme of Care priorities and in particular:

- supporting services to meet the essential standards of care;
- improving outcomes for patients and their families, and;
- supporting commissioners to achieve improved operating consistency and access for patients.
