Manjit:

- High demand for certain doctors e.g. Dr Waheed (inability to get appointments as he has 3
 on line appt, 3 pre-bookable that leaves only 6 on the day appointments)
- It will be useful to see if the high demand Dr's have lower DNA rates?
- People don't register child when they are born (only come when child has problem)
- Half of the building is **empty** (unoccupied rooms can be used for useful purposes/services)
